Terms and Conditions

General: This quote is valid for 30 days from date of issue and is subject to owner approval and availability of aircraft and crew. This quote is based on the specific aircraft model and tail number indicated. Should that aircraft become unavailable due to unforeseen circumstances every effort will be made to secure an equivalent aircraft. Itinerary changes are permitted, but also subject to owner approval and availability of aircraft and crew; your cost will be adjusted accordingly.

Cancellation and Payment Terms: Cancellation policies are established on the Charter Quote (usually one flight hour with less than 48 hours notice). Any one-way quotes are non-refundable. All trips are Pre-Pay only unless other arrangements are made.

Documentation: US government regulations require all passengers over the age of 18 to present a valid government-issued ID prior to boarding. In the absence of this security mandate, two other forms of valid ID, one of which must be issued by a government agency, may be presented. Sky Quest LLC is prohibited from transporting any person who fails to produce identification. Any parent or legal guardian traveling with a child (children) under the age of 14 years of age, without accompaniment of the other parent or legal guardian must provide a duly notarized letter of consent from the absent parent or legal guardian before that child (children) will be allowed to depart on an international flight. Passengers are responsible for obtaining and carrying all required passport and visa documents for international travel.

Responsibility: Aircraft managed by Sky Quest LLC are operated under FAA Part 135 Air Carrier Certificate No. YQKA815J; contract aircraft are operated under their respective FAA Part 135 Air Carrier Certificates, in which case you shall hold harmless Sky Quest LLC against any and all losses. Charter Customers or Brokers shall be liable for any damage to the aircraft arising from their or their clients actions.

Taxes: All charter customers, with the exception of Brokers or Management Companies, will be charged tax. It is the responsibility of the Broker or Flight Management Company to collect and remit all applicable taxes and domestic segment fees.
